### ARTICLES OF ORGANIZATION

The undersigned, as a member of the Company, pursuant to Chapter 608, Florida Statutes, files the following Articles of Organization establishing a Florida limited liability company named **DOWNTOWN PROPERTIES OF FLORIDA, LLC**.

### ARTICLE I

### Name

The name of this limited liability company shall be **DOWNTOWN PROPERTIES OF FLORIDA**, LLC (the "Company").

#### ARTICLE II

### Address
