**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION**

OF

EUROPEAN FLIGHT TRAINING, L.C.

The undersigned members of European Flight Training, L.C., under the Florida Limited Liability Company Act, adopt the following Amended and Restated Articles of Organization for said limited liability company.

**ARTICLE I
Name**

The name of the limited liability company shall be European Flight Training, L.C. (the "LC").

**ARTICLE II
Duration**

This LC shall exist perpetually, unless dissolved according to law or as set forth in the LC's Operating Agreement.

**ARTICLE III
Purpose**

The LC is organized pursuant to the Florida Limited Liability Company Act for the purpose of conducting any lawful activity in Florida, with the powers described in the Florida Limited Liability Company Act and as set forth in the LC's Operating Agreement.

**ARTICLE IV
Business Address and Registered Agent**

The address of the place of business in this State of the LC shall be 3800 St. Lucie Blvd., Fort Pierce, Florida 34946.

The name and address of the LC's registered agent shall be Charles W. McKinnon, Esq., located at McKinnon & Hamilton, PLLC, 3055 Cardinal Drive, Suite 302, Vero Beach, Florida 32963.

ARTICLE V
Members and Contributions

(a) The following are the members of the LC:

Brax Holdings, Inc. and Aviator Management, LLC

(b) The members have not agreed to make any additional contributions, but may agree to do so in the future upon the terms and conditions set forth in the Operating Agreement of the LC.

ARTICLE VI
Admission of Additional Members

Additional members may be admitted to the LC upon the unanimous consent of all members in writing and then only upon the condition that a new member be bound by and become party to the Operating Agreement of the LC.

ARTICLE VII
Dissolution, Continuation

The members shall have the right to continue the LC upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or occurrence of any other event which terminates the membership of a member in the LC, so long as a majority of the remaining members agree to continue the LC.

ARTICLE VIII
Management

The LC is to be managed by a Manager or Managers. The name and address of the initial Manager of the LC who shall serve as Manager until a successor is elected and qualified is:

The Manager may be removed and replaced by the members, as provided in the Operating Agreement of the LC. The Manager shall hold the offices and have the responsibilities accorded to him by the members as set out in the Operating Agreement of the LC.

ARTICLE IX
Additional Provisions

(a) All members of the LC shall be entitled to vote on matters relating to the LC per capita and not in proportion to their contributions to the capital of the LC unless as otherwise set forth in the Operating Agreement of the LC.

(b) Management decisions shall be made by majority vote of the members.

(c) The effective date of this limited liability company is November 30, 2000.
