NAME**

The name of the limited liability company is Casa Tua Hotel & Restaurant Company L.L.C. (the "Company").

**ARTICLE II  
DURATION**

**ARTICLE VI**  
**ADMISSION OF NEW MEMBERS**

Members of the Company shall have the right to admit additional members to the Company upon such terms and conditions as shall be determined by the members of the Company.

**ARTICLE VII**  
**TERMINATION OF EXISTENCE**

The death, retirement, resignation, expulsion, termination of employment by the Company, conviction of a crime, bankruptcy or dissolution of a Member shall not dissolve the Company unless a majority in interest of the remaining Members consents to dissolve the Company.

**ARTICLE VIII**  
**MANAGEMENT**

The Company shall be manager managed in accordance with the regulations of the Company. Initially, there shall be one manager of the Company. Thereafter, the number of managers shall be determined as provided in the regulations of the Company. The managers shall be elected by the members as prescribed and provided in the regulations of the Company and by Florida law. The managers shall hold the offices and have the responsibilities set forth in the regulations of the Company. The regulations of the Company may also contain any other provisions for the regulation and management of the affairs of the Company not inconsistent with law or with these Articles of Organization. 


**STATEMENT OF ACCEPTANCE OF REGISTERED AGENT**
