The undersigned member hereby executes and acknowledges these Articles of Organization for the purpose of forming a Limited Liability Company in accordance with the laws of the State of Florida:

ARTICLE I Name

The name of this Limited Liability Company shall be:

ARTICLE II Existence and Period of Duration
