OF

Article I

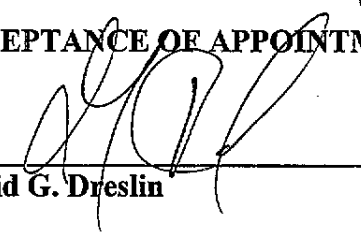
Article VIII

DISSOLUTION

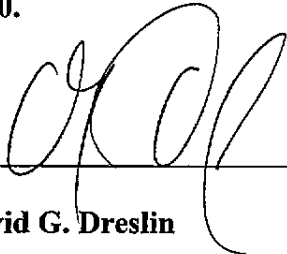
This Company shall be dissolved with the written consent of all its Members.
