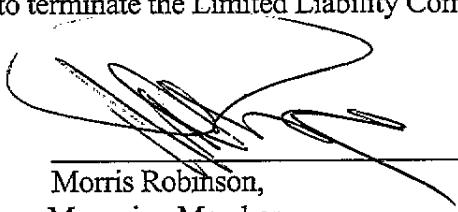
ARTICLE V. ADMISSION OF ADDITIONAL MEMBERS

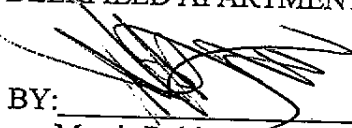

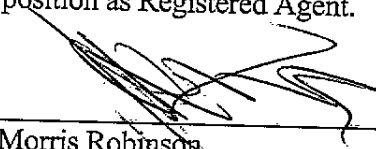
