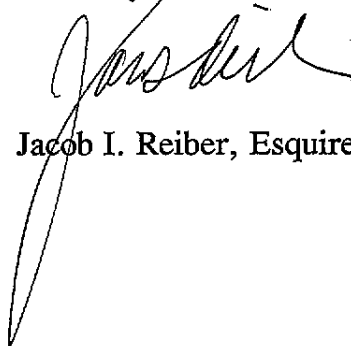

ARTICLES OF ORGANIZATION

OF

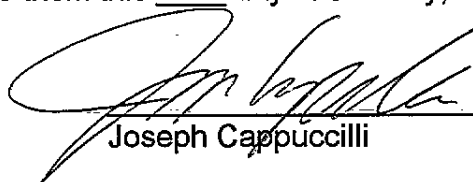

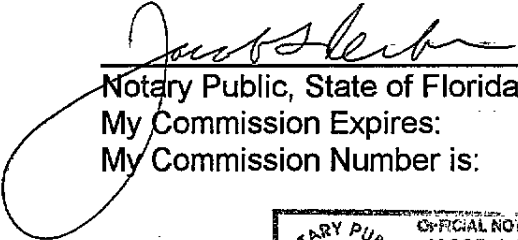

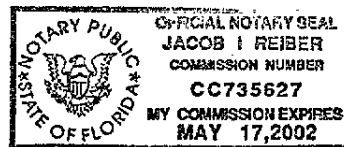
