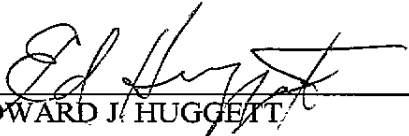
ARTICLE VII – CONTINUATION OF BUSINESS

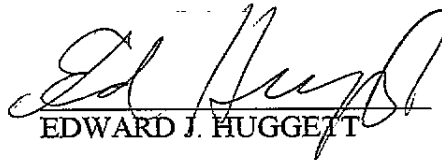
