## A FLORIDA LIMITED LIABILITY COMPANY

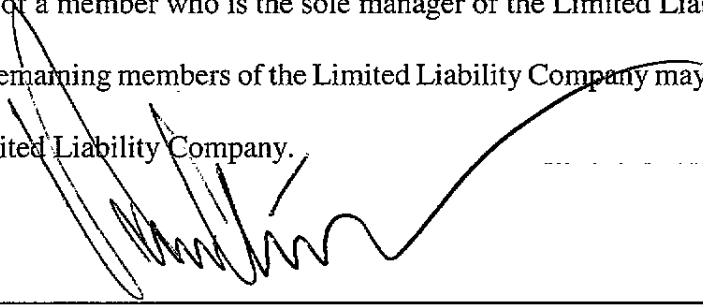

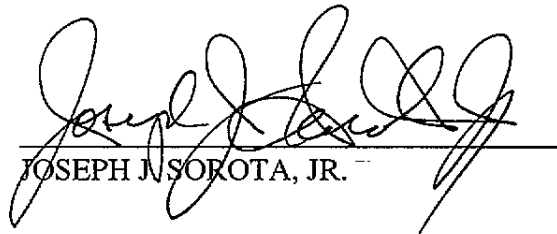

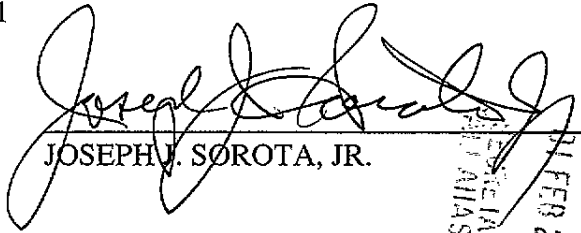
