**ARTICLES OF AMENDMENT OF  
1ST STREET 8 UNIT CONDO, L.L.C.**

**THE UNDERSIGNED, WILLIAM K. LOVELACE**, being the authorized representative of the Members of 1ST STREET 8 UNIT CONDO, L.L.C., does hereby certify that the following Amendment to the Articles of Organization of 1ST STREET 8 UNIT CONDO, L.L.C. was approved by the Members of said Corporation on the 5th day of April, 2001, at a duly called meeting of the Members.

The Articles of Organization of 1ST STREET 8 UNIT CONDO, L.L.C. are hereby amended as follows:

1. Article VIII is hereby deleted and the following is inserted in lieu thereof:

**ARTICLE VIII  
CAPITAL CONTRIBUTIONS, PROFIT/LOSS ALLOCATION  
AND MEMBER VOTING**

A. Initial Contributions. The total amount of cash or property to be initially contributed by each of the initial members of the of the Company is as follows:

B. Profit/Loss Allocation. The profits and losses of the Company shall be allocated among the members in accordance with the Regulations of the Company.

C. Member Voting. All members of the Company shall be entitled to vote on matters relating to the Company. Each Member's vote shall be weighted in accordance with the Regulations of the Company.

D. Additional Contributions. The Members shall make additional capital contributions from time to time, as required by the Regulations adopted by the Company.

2. All amendments included herein were adopted pursuant to Florida Statutes, and there is no discrepancy between the Corporation's Articles of Organization as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.
