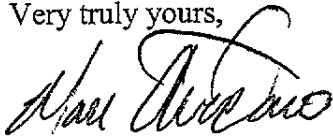

ARTICLES OF ORGANIZATION

FOR

WOODFIELD GREENS COUNTRY CLUB ESTATES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is WOODFIELD GREENS COUNTRY CLUB ESTATES, LLC.

ARTICLE II - DURATION

This limited liability company shall have perpetual existence until it is dissolved and its affairs wound up in accordance with the Florida Limited Liability Company Act.

ARTICLE IV - REGISTERED AGENT AND OFFICE

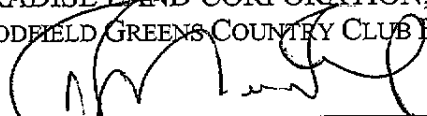
