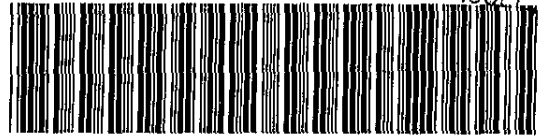

- FIRST: This Articles of Amendment amends the Articles of Organization of **Kilcoyne - C.J. Properties, LLC**.

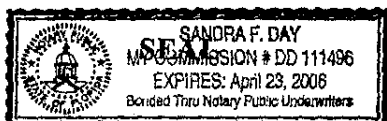
- FIFTH: The amendment is effective as of the date of filing hereof and does not affect the management and/or the designated Managers of the Company.


