The undersigned, for the purpose of forming a limited liability company under the Florida Limited

Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

- 1. Name. The name of the Limited Liability Company shall be Willow Company, L.L.C. ("Company").
- 2. <u>Duration.</u> The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
- 3. <u>Place of Business</u>. The mailing and street address of the principal office of the Company is 2400 First Street, Soite 202, Fort Myers, Florida 33901.
- 4. <u>Registered Office and Agent.</u> The name and street address of the initial registered agent of the Company in the State of Florida is Steven W. Hubbard, Esq., 2320 First Street, Suite 1000, Fort Myers, Florida 33901.
- 5. <u>Management</u>. The Company shall be a manager-managed company. The Company shall be managed by the manager or managers elected or appointed by the members in accordance with the Regulations or Operating Agreement (in either case, "Operating Agreement") to be adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
