ARTICLE III – REGISTERED AGENT AND REGISTERED OFFICE

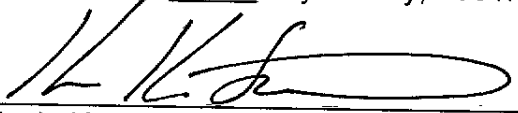

The Company is to be a manager-managed company.

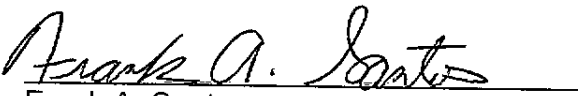
