ARTICLES OF ORGANIZATION FOR  
FLORIDA LIMITED LIABILITY CORPORATION

**ACCESS PROCUREMENT AGENCY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - Name:

The name of the Limited Liability Company shall be: Access Procurement Agency, LLC.

ARTICLE IV - Management

The limited liability company is to be managed by one manager or more managers who are also Members, and is, therefore, a Member - managed company.

The limited liability company shall be managed by a Member Manager in accordance with the Operating Agreement adopted by the members for the management

of the business and affairs of the company. Management shall be vested in the Members in proportion to the interest of Members in the profits of the limited liability company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with Florida law or these articles of organization. **ARTICLE V -- Duration**

The limited liability company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the Operating Agreement of the company.

**ARTICLE VII -- Additional Capital Contributions**

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members or as provided in the Operating Agreement of the company.

**ARTICLE VIII -- Admission of New Members**

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the Operating Agreement the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer and / or management participation by

unanimous written consent.

ARTICLE IX -- Members' Right to Continue Business

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous written vote of the remaining members.

ARTICLE X - Effective Date

The Effective Date of the limited liability company known as Access Procurement Agency, LLC shall be May 24, 2001.

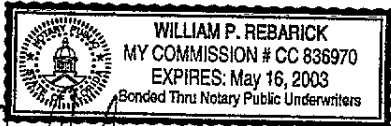

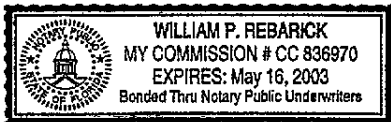
