**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION

*Pursuant to the provisions of section 608.411, Florida Statutes, the undersigned limited liability corporation adopts the following articles of amendment to its articles of organization:*

**FIRST:** The date of filing of the articles of organization was June 1, 2001.

**SECOND:** The following amendment to the articles of organization was adopted by the limited liability company:

Resolved that section 2 of the Articles of Organization be, and the same hereby is deleted in its entirety and the following be, and hereby is adopted in substitution therefore:

**2. Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of (i) thirty (30) years from the date of filing or (ii) the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
