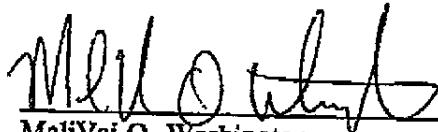
2. Initial Registered Agent. The name and address of the initial registered agent in Florida for the Company is:

3. Management. The Company is to be managed by one manager or more managers and is therefore a member-managed company.

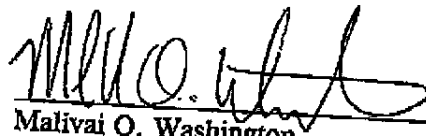
