The name of this limited liability company is LAKES EDGE COMMERCIAL PROPERTIES, LLC, a Florida limited liability company.

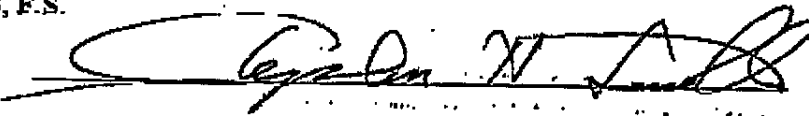

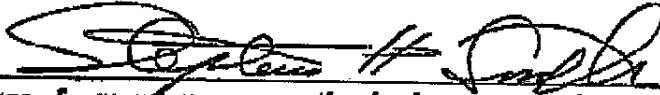
