**ARTICLE I**

Name and Duration

The name of this Limited Liability Company is ADD SOURCE MEDIA, LLC (hereinafter referred to as the "Company"). The duration of the Company shall be perpetual.

The Company shall be managed by Members.


**ARTICLE VI**


**REGISTERED AGENT CERTIFICATE**
