Pursuant to Section 608.411 of the Florida Limited Liability Company Act, the undersigned, who are all the members of **DAVIDSON, JAMIESON & CRISTINI, CPA'S, LLC** amend the articles of organization of the limited liability company originally filed with the Secretary of State of the State of Florida on July 13, 2001, as follows:

1. ARTICLE I., NAME AND PRINCIPAL PLACE OF BUSINESS, is hereby amended, changed and altered so that it reads as follows:

ARTICLE I.

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be **DAVIDSON, JAMIESON & CRISTINI, PL**, and its principal office shall be located at 1956 Bayshore Boulevard, Dunedin, Florida 34698, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
