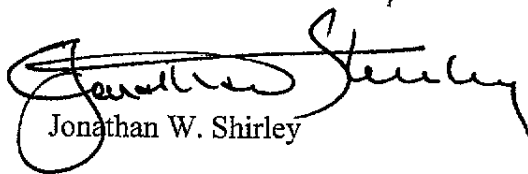

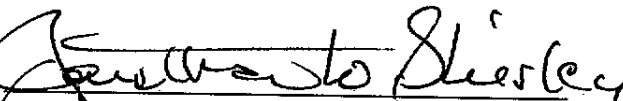
ARTICLE VI

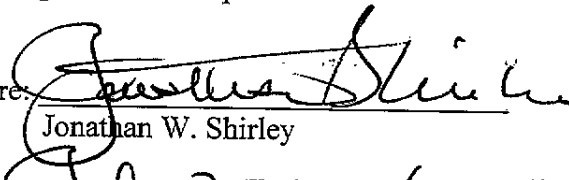
ARTICLE VII
