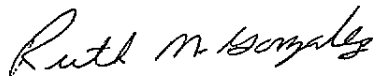

AMENDMENTS**

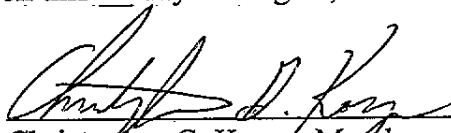

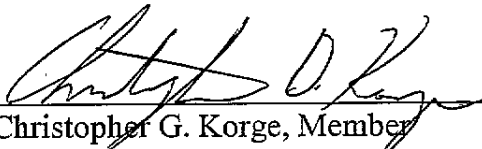
