

**ARTICLE IV. MANAGEMENT**





**ARTICLE V. DURATION**

This Limited Liability Company shall commence its existence on the date these Articles of Organization are filed with Florida Department of State. The company's existence shall be perpetual, unless the company is earlier dissolved as provided in this Articles of Organization.

**ARTICLE VI. PURPOSES AND POWERS**

Policies and Regulations of American National Employment & Training Agency, LLC, but the transferee shall have not have any right to participate in the management of the Company, unless an additional written employment contract agreed and signed. The transferee shall not become a member, unless all the members of the Company, other than the member proposing to dispose of his or her interest, approve and accept the transfer by a written consent. The existing members shall determine the amount and nature of the contributions proposed by new members at the time those new members are admitted.

ARTICLE VIII. CONTINUATION OF BUSINESS

The remaining members of American National Employment & Training Agency, LLC have right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event, which terminates the continued membership of a member in the Company. The business operation may be continued only upon the written consent of the remaining members, otherwise the Company shall be dissolved.
