## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF PORT ORANGE AIRPORT ROAD, LLC

The Articles of Organization of Port Orange Airport Road, LLC a Florida limited liability company (the "Company"), as previously amended, are further amended as set forth in these Articles of Amendment:

- 1. The name of the Company is Port Orange Airport Road, LLC.
- 2. The date of filing of the Company's Articles of Organization was August 31, 2001.
- 3.
