ARTICLES OF ORGANIZATION

OF

SPRINGFIELD & MAIN, LLC

ARTICLE I - NAME

The name of the Limited Liability Company is Springfield & Main, LLC (the "Company").

ARTICLE II - ADDRESS

ARTICLE III - INITIAL REGISTERED AGENT

ARTICLE VI - MEMBERS RIGHTS TO CONTINUE BUSINESS



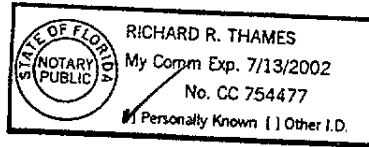


