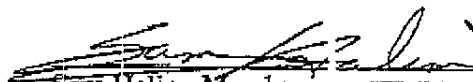
1. The name of the Company as filed on September 25, 2001, with the Florida Department of State is PHYSICIANS CARDIAC IMAGING, L.L.C.
