### ARTICLES OF MERGER OF TRI-COUNTY ANESTHESIA, L.L.C. and TRI-COUNTY ANESTHESIA MANAGEMENT, L.L.C. WITH AND INTO ANESTHESIA SOLUTIONS OF CENTRAL FLORIDA. L.L.C.

Pursuant to the provisions of Section 620.201 and 608.438 of the Florida Statutes, the undersigned do hereby adopt the following Articles of Merger:

#### ARTICLE I - PLAN OF MERGER

# PLAN OF MERGER OF THE TRI-COUNTY ANESTHESIA, L.L.C. AND TRI-COUNTY ANESTHESIA MANAGEMENT, L.L.C. WITH AND INTO ANESTHESIA SOLUTIONS OF CENTRAL FLORIDA, L.L.C.

- 1. TRI-COUNTY ANESTHESIA, L.L.C., a Florida limited liability company, and TRI-COUNTY ANESTHESIA MANAGEMENT, L.L.C., a Florida limited liability company, shall merge with and into ANESTHESIA SOLUTIONS OF CENTRAL FLORIDA, L.L.C. a Florida limited liability company, with ANESTHESIA SOLUTIONS OF CENTRAL FLORIDA, L.L.C. as the surviving entity.
- Upon the consummation of the merger of TRI-COUNTY ANESTHESIA, 2. L.L.C. and TRI-COUNTY ANESTHESIA MANAGEMENT, L.L.C. with and into ANESTHESIA SOLUTIONS OF CENTRAL FLORIDA, L.L.C., the separate existence of TRI-COUNTY ANESTHESIA, L.L.C. and TRI-COUNTY ANESTHESIA MANAGEMENT, L.L.C. shall cease.
