

*The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization*

**ARTICLE I NAME**

Without the unanimous approval of the remaining members, any such punitive transfer of a member's interest shall not entitle the would-be-transferee management of this Limited Liability Company and shall entitle the would-be-transferee solely to and to be a charge upon (I) the share of income of, and (II), when as if declared unanimously by the remaining members, distributions, by way of profits, return of capital, or otherwise, from this Limited Liability Company, but not including any compensation paid to the would-be-transferee for services rendered to the Limited Liability Company.

**ARTICLE IX WITHDRAWAL, RETIREMENT, DEATH, BANKRUPTCY OR EXPULSION**


