THEREFORE the Articles of Organization of 6630 Nature Preserve LLC are amended to read:

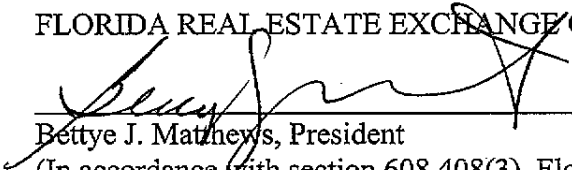
ARTICLE I
