ARTICLE 1. Name: The name of the Professional Limited Liability Company shall be Vilar, Duty & Montero, P.L.



ARTICLE 4: Management: Vilar, Duty & Montero, P.L. is to be a member-managed professional limited liability company.



ARTICLE 6. Practice of Law: Vilar, Duty & Montero, P.L. exists for the practice of law.


