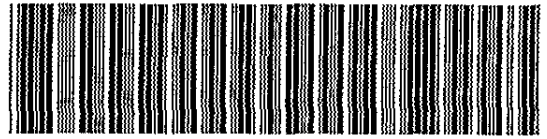



FIRST: The date of filing of the Articles of Organization of Vilar, Duty & Montero, P.L. (the "Company") was November 19, 2001.


SECOND: The following amendments to the Articles of Organization were adopted by the Company:


Article 1. Name: The name of the professional limited liability company shall be Vilar & Montero, P.L.
