## ARTICLES OF ORGANIZATION

# ARTICLE I

The name of this limited liability company is Huxter's, LLC, a Florida limited liability company (the "Company").

# ARTICLE II

The Company shall have perpetual existence, commencing upon the date of these Articles with the Florida Department of State.

# ARTICLE III PURPOSE
