OF

**ARTICLE I
NAME**

The name of this limited liability company is Huxter's, LLC, a Florida limited liability company (the "Company").

**ARTICLE II
DURATION**

The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

The undersigned executed these Articles of Organization effective as of the 26th day of November, 2001.



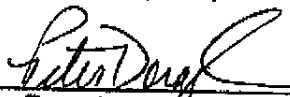
