Article II

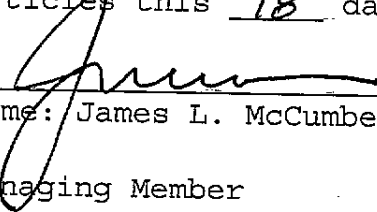
Initial Registered Office and Agent
