ARTICLE 1 – Name. The name of the limited liability company shall be La Familia Medical Clinic, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall 5806 Viking Road, Orlando, Florida 32808.


