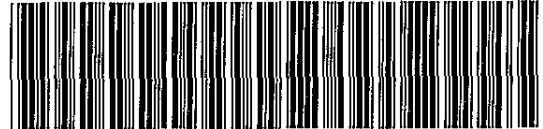

The name of this limited liability company (the "Company") is **PREMIER/LUTGERT TITLE, LLC.**"


4. These Articles of Amendment shall be effective when filed with the Florida Department of State.


