The mailing address and street address of the principal office of the Limited Liability Company is 1488 Forand Circle, Port Charlotte, Florida 33952.


ARTICLE III — Registered Agent & Registered Office




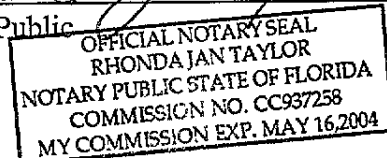
