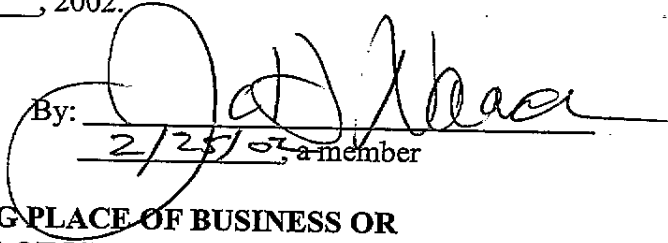
ARTICLE V - AMENDMENT

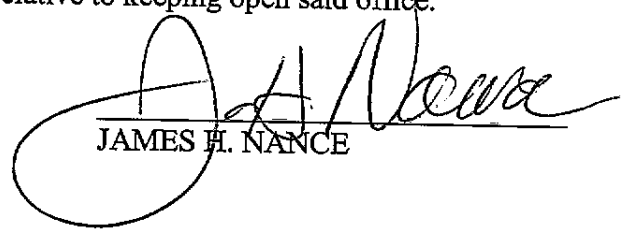
