ARTICLE V – EFFECTIVE DATE

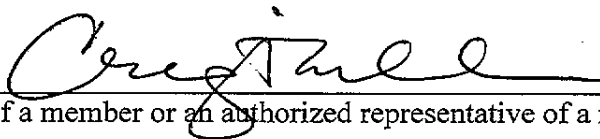
The effective date of the Limited Liability Company is February 25, 2002.
