**ARTICLES OF AMENDMENT TO
THE ARTICLES OF ORGANIZATION
OF PHYSICIAN REFERRAL DIRECTORY, L.L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida company hereby adopts the following Articles of Amendment to its Articles of Organization:

Article I - Name and Date of Filing

The name of the company is PHYSICIAN REFERRAL DIRECTORY, L.L.C. (hereinafter referred to as the "Company"). The Articles of Organization of Company were originally filed on March 29, 2002.

Article II - Adoption and Text of Amendments
