1. **Name.** The name of the Limited Liability Company is Select Properties, L.L.C.
2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the State of Florida.

4. **Term.** Term of this L.C. shall be perpetual.
