The name of the limited liability company is: MV PROPERTIES, LLC

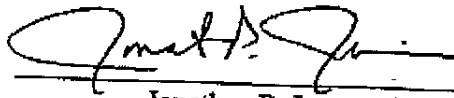
ARTICLE II. ADDRESS

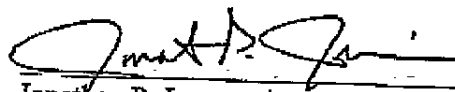
