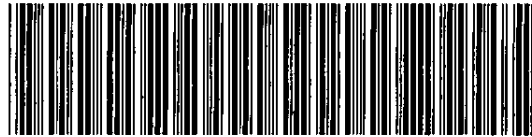

Article IX DISTRIBUTIONS of PROFITS AND LOSSES


ARTICLE IX
