The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter $\overline{608}$, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be FAMILY BANK DESIGN CENTER, LLC ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 100 Cr. Oak Centre Drive, Longwood, Florida 32750.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified.
