

ARTICLES OF ORGANIZATION JEAN CARPER ENTERPRISES, LLC

THE CORPOR DAILS OF The undersigned natural persons of the age of eighteen years or more, acting as Organizers of a Limited Liability Company under the Florida Limited Liability Company adopt the following Articles of Organization:

- 1. The name of the Limited Liability Company is the Jean Carper Enterprises, LLC (the "Company").
