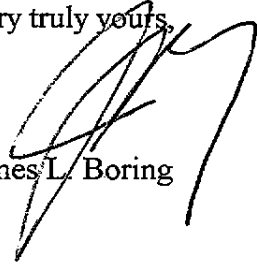

**ARTICLES OF ORGANIZATION  
OF  
JEAN CARPER ENTERPRISES, LLC**

The undersigned natural persons of the age of eighteen years or more, acting as Organizers of a Limited Liability Company under the Florida Limited Liability Company Act, adopt the following Articles of Organization:

1. The name of the Limited Liability Company is the Jean Carper Enterprises, LLC (the "Company").
2. The term of the Company shall begin on the date the Articles of Organization are filed and received for recordation by the Department of State of Florida and shall continue in full force and effect in perpetuity unless sooner terminated in accordance with the Operating Agreement.
3. The Company is, without limitation, authorized to write, publish, and advertise publishable material, books, articles, columns and to acquire, buy, hold, sell, manage, operate and otherwise deal with, obtain financing for, exchange, hold for investment, maintain, sell or otherwise dispose of publishable material, books, articles, columns, personal property and any other assets of all types, and to engage in any and all activities related or incidental thereto.  
  
The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act and shall have and may exercise all powers and rights which a limited liability company may exercise legally pursuant to the Florida Limited Liability Company Act.
4. The initial Operating Agreement of the Company shall be in writing and adopted by its members. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
5. The Company shall be a "manager-managed limited liability company" within the meaning of the Florida Limited Liability Company Act, and no member of the Company, solely by reason of such member's membership in the Company, shall be considered or relied upon to be an agent of the Company for the purpose of binding the Company with respect to any transaction or other obligation whatsoever. The initial Manager shall be Jean E. Carper. The Manager may be changed as provided in the Operating Agreement. The Manager shall have full authority to manage the business of the Company and to make all decisions regarding the business of the Company.

6. The address of the initial registered office in Florida is 1500 Von Phister Street, Key West, Florida 33040.

7. The initial registered agent's name is Jean E. Carper, whose business address is 1500 Von Phister Street, Key West, Florida 33040. The registered agent is the manager of the Company.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.
