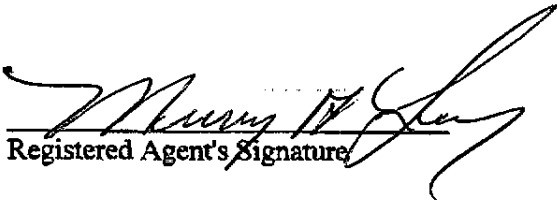

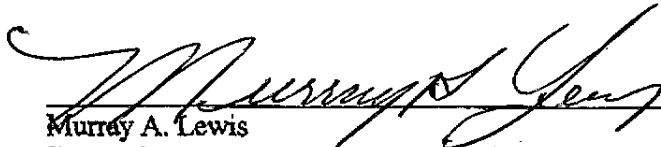
**ARTICLE V**
