## ARTICLES OF ORGANIZATION

#### FOR

# ROBBINSON DEVELOPMENT, LLC

# A FLORIDA LIMITED LIABILITY COMPANY

The undersigned as organizers and Members of Robbinson Development, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes adopt the following Articles of Organization:

#### ARTICLE I - NAME
