#### AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BRANCH LOGISTICS, LLC

The name of the Limited Liability Company is Branch Logistics, LLC. The name under which Articles of Organization were originally filed was Branch Leasing, LLC.
