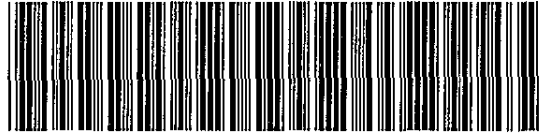

Article I, Name, of this limited liability company's Articles of Organization is hereby deleted in its entirety, and the following is substituted in lieu thereof:


ARTICLE I - NAME
